





CAR & EASA Part-M Subpart G & I – 2 Days

INTRODUCTION

Commission Regulation EC 1321/2014 Annex I (Part-M) specifies that an aircraft owner or operator is responsible for the continuing airworthiness of its aircraft.

Subpart G focuses on the specific obligations of the Continuous Airworthiness Management Organisation (CAMO) to manage the Airworthiness Process.

Subpart I identifies the specific obligation to ensure the Airworthiness of the aircraft through the performance of the Airworthiness Review Certificate (ARC) process.

In the UAE CAR Part M fully describes the above requirements in respect of UAE Aircraft. In the case of large aircraft, not engaged in Commercial Air Transport (CAT), this activity may be contracted to an approved Continuing Airworthiness Management Organization (CAMO).

SAS Training is extremely practical and focuses on the understanding of the knowledge and skills required to understand fully Subpart G & I with specific attention given to Subpart G (CAMO) and Subpart I (Airworthiness Review Certificates) and its Guidance Material.
