This is an industry specific 3-day intensive program developed for all persons who are involved with the day to day management as well as those who are working within the environment. In addition, it will be appropriate for Quality Auditors and of interest to the senior management and executive team.

The training focuses on both ICAO as a core recommended practice and EASA as a developed regulatory environment, in all cases reference is made to best practice behaviors.

This course covers all subject matter to an initial level and is suitable and effective for new starters, It will also serve as an acceptable course for the purpose of recurrent and refreshment of "Airside Safety Training" for all personnel working on the airside.
