### INTRODUCTION

The Practical Assessor should be fully aware of the aim of the assessment and be able to conduct a practical assessment in such a way that the true abilities of the candidate are demonstrated.

These involve technical abilities but also the ability for the candidate to satisfactorily perform the tasks in an actual maintenance environment where basic principles of human factors apply (such as work performed under stressful conditions i.e. time or management pressure etc).

Practical Assessor should remain neutral at all times, and behave in a manner that will not influence or prejudice the final result of the assessment, for example by providing assistance to a stressed candidate

This two-days training course considers in detail the Roles and Responsibilities and Regulatory Obligations of Practical Assessors Working in the Part-147 environment.

It reviews in depth the relevant EASA Part-66/147/ rules (including AMC/GMs) together with Best Practice Industry and MTOE Procedures.

This course is highly relevant for both existing and newly appointed (trainee) Practical Assessor.

The Course is highly practical and focuses on the development of appropriate soft skills required to support and develop the role of Practical Assessor.
