It is generally accepted that the most effective HF training, is training which is takes into full account specific organizational issues, and has a direct connection with the Quality and Safety System of the organization.

The course is highly practical, and promotes best training practices. It is an industry specific four-day program specifically designed for those who need to manage, or deliver Human Factors Training. The HFTTT course stimulates involvement and provides for powerful motivation. To also introduce the delegate to training skills and to provide the confidence which can be developed to deliver effective Human Factors Training within your organizations.
