## Introduction

Considers the following subparts Subpart G – Concerns Production Organisation Approval (POA) (Concerns the rules for showing compliance of products, parts & appliances with the relevant design data. Requires Production Organisation Exposition (POE))

Subpart H – Concerns Airworthiness Certificates – New Aircraft Certificate of Airworthiness – issued upon presentation to the Competent Authority (CA) or National Aviation Authority (NAA) of a Statement of Conformity In accordance with the requirements of Subpart F or G or with an export certificate of airworthiness

Subpart I – Concerns the issue of Noise Certificates – New aircraft – Noise certificate issued upon presentation of relevant documentation (statement of conformity or similar if from outside the EU) (Used aircraft – Noise certificate issued upon presentation of noise information and appropriate Records)

Subpart P – Concerns Permit to Fly Procedures – (Used where the C of A is temporarily invalid or cannot be issued but the aircraft is capable of performing a safe flight
