

# EASA Regulation 965 Part SPA – Specific Approvals for Regulatory Authorities – PBN, MNPS, RVSM, LVO & ETOPS – 2 Days

#### Introduction

EASA Part SPA was issued as Annex V to Commission Regulation 965/2012. Part SPA provides for the Implementing Rules, (IRs), Acceptable Means of Compliance, (AMCs), and Guidance Material, (GMs) related to Specific Approvals which are available for an Air Operator Certificate (AOC) –Air Carrier (AC) to apply for.

This course will review the framework of the following Specific Approvals: ETOPS (Extended Range Operations with Two EnginedAeroplanes)
RSVM (Reduced Vertical Separation Minima)
PBN (Performance Based Navigation)
LVO (Low Visibility Operations)
MNPS (Specified Minimum Navigation Performance)
AWOPS (All Weather Operations)
