What Audits Can Be Delivered?

EASA Part CAMO Compliance

This audit looks at the Operators Compliance with the requirements of Part CAMO The audit takes a full day and covers in depth all elements of compliance with Part M & Part CAMO Regulations, and determines the effectiveness of

- The Part M Management Organisation
- The Effectiveness of the Quality Audit System
- The Effectiveness of the Safety Management System.

EASA Part 145 / Part CAO Organisation Audit

This audit looks at the Compliance of the 145 organizations with all regulatory requirements
This audit takes a full day and covers in depth all elements of compliance with Part 145 Regulations, and determines

- The Effectiveness of the Production Management System
- The Effectiveness of the Quality Audit System.

Aircraft Compliance and Conformity Audit
