

# EASA Regulation 1178/2011 Including EASA Part FCL Overview Training - 3 Days

#### Introduction

Flight Crew Licencing (FCL) in Europe - Commission Regulation (EU) No 1178/2011 of 3 November 2011 lays down technical requirements and administrative procedures related to civil aviation aircrew pursuant to Regulation (EC) No 216/2008 of the European Parliament and of the Council.

The European Aviation Safety Agency (European Aviation Safety Agency (EASA)) was given, under Regulation (EC) No 216/2008 full legal responsibility for Flight Crew Licensing in the European Union States.

EASA is able to rely upon the support of the NAAs in the Member States acting as Qualified Entities to implement FCL.

The EASA 'Basic Regulation' - ARTICLE 20 - ESSENTIAL REQUIREMENTS Regulation (EU) 2018/1139

Pilots and cabin crew involved in the operation of aircraft referred to in point (b) of Article 2(1), other than unmanned aircraft, as well as flight simulation training devices, persons and organizations involved in the: training, testing, checking, or medical assessment of those pilots and cabin crew.

As well as flight simulation training devices, persons and organizations involved in the : training, testing, checking, or medical assessment of those pilots and cabin crew. The Rules comprise two sets of requirements,

- · Covering FCL
- · Covering medical certifications for all personnel licensing purposes.

The purpose of this three-day course on is to consider in detail the obligations affecting EASA Air Crew Regulation. A review of EASA Basic Regulation 2018/1139 is provided together with a comprehensive introduction to the annexes contained in EU Regulation 1178/11 and Amending Regulations for Air Crew.

The Acceptable Means of Compliance (AMC) and Guidance Material (GM) to Part-FCL and Part-MED was adopted by the Agency and published on the Agency's webpage in December 2011. (ED Decision 2011/016/R AMC and GM Part-FCL and ED Decision 2011/015/R AMC and GM Part-MED). Additionally in April 2012: ED Decision 2012/005/R (GM to Part-CC), ED Decision 2012/006/R (AMC and GM to Part-ARA), and ED Decision 2012/007/R (AMC and GM to Part-ORA).

#### Who is the course for?

The course is for various aviation personnel, including pilots, flight instructors, flight examiners, and anyone involved in the administration and oversight of flight crew licensing within the European Union.
