

## **ATO Compliance Monitoring Intensive Training Course – 2 Days**

### **Introduction**

The introduction of Regulation (EU) 1178/2011 saw the requirements for Compliance Monitoring was introduced in lieu of Quality Systems for FTOs and TRTOs. It also saw the introduction of Compliance Monitoring for Registered Facilities.

This course was developed to be equally relevant for those ATOs for whom Compliance Monitoring and Quality Systems are new concepts and those for whom the new requirements are simply a transition from their existing systems. This course was also designed to give delegates sufficient theoretical auditor training for them to then continue on to an in-company auditor training programme.

In addition, the course also includes Basic Auditor Training upon completion of which, delegates will be fully prepared to commence on-job auditor training within an ATO.

### **Who is the course for?**

This course is designed for personnel involved in Aircrew and Aircraft Maintenance Training, including ATO Quality Assurance Managers, Compliance Monitoring Managers, Training Managers, and other personnel responsible for ensuring compliance with EASA regulations related to Aircrew and Aircraft Maintenance Training.
