

Dangerous Goods Training Program – Train the Trainer – Refresher Course – 3 Days

Introduction

Dangerous Goods training is established as mandatory requirements by the International Civil Aviation Organisation (ICAO) in their Technical Instructions for the Safe Transport of Dangerous Goods by Air. In order to fulfil those requirements national competent authority of each Member State established uniform rules accordingly.

It is important that all relevant employees receive training that is commensurate with their responsibilities. In addition recurrent training must be provided within 24 months of previous training to ensure knowledge is current.

The success of a training depends of the ability of the Instructor to deliver correct and comprehensive training. It is obligation of the Dangerous Goods Instructors to “receive and understand updates to dangerous goods information and be made familiar with those changes by training or other means on an annual basis...” (DGR 1.5.7.2)

Both Regulators and IATA strongly recommend DGR Instructors to receive training on changes in DGR manual and refreshment of their instructional skills at regular basis

The course is highly practical and consist of two parts:

- Information about changes in latest edition of IATA Dangerous Goods Regulations; and
- Training design and techniques enforcement

It is a three-day program specifically designed for certified Dangerous Goods Category 6 Instructors.
