

EASA 147 Developing Training Needs Analysis (TNA) for Type Rating Training Courses - 1 Day

Introduction

The role of the Training Needs Analysis provides a process whereby the organization may maintain compliance with EASA Part 147 & Part 66 requirements in a “post” Regulation (EU) 1149/2011.

The requirement is for the TNA to include an analysis identifying all the areas and elements where there is a need for training as well as the associated learning objectives, considering the design philosophy of the aircraft type, the operational environment, the type of operations, and the operational experience.

This analysis should be written in a manner that provides a reasonable understanding of which areas and elements constitute the course to meet the learning objectives.

This course is aimed at aviation training professionals managers and quality assurance auditors who are seeking to ensure a fully compliant EASA 147-type training organization.

The course is aimed both at new entrants to EASA 147 as well as existing professionals and other stakeholders looking to polish their auditing skills.
