

FAA & EASA TSO & ETSO - 1/2 Day

Introduction

An FAA Technical Standing Order (TSO) EASA European Technical Standing Order (ETSO) is a minimum performance standard for specified materials, parts, and appliances used on civil aircraft. When authorized to manufacture a material, part, or appliances to a TSO/ETSO standard, this is referred to as TSO/ ETSO authorization. Receiving such an authorization is both design and production approval.

This ½ Day Training Course considers the process by which TSO/ETSO authority is issued, together with the process for certification - Where the TSOA article reflects a major change to type design, it may require a supplemental type certificate (STC) in order to approve the installation/modification data.

The USA may accept foreign-produced articles when the FAA itself has approved the design (using a Letter of Design Approval or LODA) AND the United States has signed a bilateral agreement with the foreign nation that accepts LODA designs that are produced under the foreign airworthiness authority's manufacturing oversight.
