In accordance with the regulatory requirements of EASA Part 147, The roles may be combined for:

The assessor and the instructor for the practical elements of the Type Rating Training; Or The assessor and the supervisor for the On-the-Job Training. Providing that the objectives associated with each role are clearly understood and that the competence and qualification criteria according to the company's procedures are met for both functions.

As part of the Competence Management Process, the individual needs of each instructor should be ascertained at both the initial and annual competency review when typically the Instructor's personal development will be discussed and any associated training needs to be assessed.

The course is highly participative and stimulates involvement and provides powerful motivation to introduce the delegate to a comprehensive understanding of the necessary processes and skills to implement effective Competence Management and Assessment processes within the organization.

The course is made for professionals working in aviation maintenance training organizations operating under EASA Part 147.
