### Introduction

A significant percentage of Accidents and Incidents occur when the aircraft is parked at the Airport or is being serviced or attended to during a transit check or layover. For the operators, an accident or incident often causes expensive delays and usually has multiple repercussions. For the passengers, accident or incident-related delays cause missed connections or spoiled holidays or business trips.

Whilst the operator is responsible for all activities taking place in support of its operations, each separate activity usually is delivered as a subcontracted activity provided by the subcontract organization. In accordance with the EASA regulatory approval supporting the AOC (Air Operators Certificate) The ultimate responsibility for compliance with the regulations remains with the Operator. During Subcontract Audits the Operator looks at the Subcontract organization's ability to manage its workforce in respect of Competency and meeting and managing the ongoing training requirements. We know that Human Factors play a significant role in the cause of Aircraft Accidents and Incidents with approximately 80% of today's Accidents and Incidents caused by Human Error.
