EASA Provides a regulatory environment with Implementing Procedures, Acceptable Means of Compliance, Guidance Material, Certification Specifications, and User Guides.

All audits typically aim to ensure visible compliance is determined with the various objectives called for through the myriad of obligations. To demonstrate compliance with all requirements, organisations create a raft of documents, processes, and procedures.

A degree of objectivity is typically required during assessments of organisational document processes and procedures to enable demonstration of compliance with both external regulations and internal organisational compliance.

This course does not address in detail the underlying regulations but considers the due process to deliver effective audit oversight for each of the key areas and process
