To achieve an EASA Part-145 approval is both a credit to any organisation as well as a major challenge. You should have the following in place:

- Sufficient financial resources
- Company structure with sufficient competent manpower
- Maintenance Organization Exposition (MOE)
- Compliance (Quality System)
- Safety Management System
- Appropriate facilities

These are the primary requirements that you must meet to be able to submit an EASA Part-145 approval application. EASA Form 2
