- Shorter courses leave less time for in-depth exploration of complex topics, which may result in superficial understanding.
- $_{\odot}$ Critical skills and knowledge may be glossed over, impacting long-term competency.
- Attempting to condense five days' worth of material into three days can overwhelm students, leading to cognitive fatigue. This, in turn, can negatively affect retention and application of the course material.

• Mitigating the Risks to Support Sofema Clients

- To minimize the potential downsides of course redaction, several strategies can be employed including Conducting a pre-course assessment of students' current knowledge and experience levels can help instructors tailor the course content more effectively.
- o This ensures that essential topics are covered for beginners, while more advanced students are still challenged.
