How long is the Corporate Freedom Pass Valid?

- We look forward to welcoming you to the program and wish you a great learning opportunity and experience!

Conditions for Using the Freedom Pass

- Either 5, 7, 10 or 15 Courses are opened at 1 time.
- Once completed you can request the next course or batch of courses.

Note - Enrollments will normally be completed no later than 24 hours following the request using the provided enrollment form

- Typically requests during AM will be completed same day and requests during PM will be completed at the start of business during the following work day.
- The delegate has 3 attempts at the examination and can be enrolled a second time following intervention from your QA department or nominated Training Account Manager (Note our current failure rate is less than 0.05%)

Client Auto Enrollment

- We are pleased to share that Corporate Freedom Pass Clients are now responsible to self-enroll your own delegates - means you can take full control of your organisation's enrollment process and as soon as a delegate has completed a training, you can enroll the next one and so on within your allowance of concurrent users.
- Client Nominated Administrator has Full Control of Registrations.
- Cost Effective allows for more enrollments within your CFP.
- Full Admin Guidance and Support from Sofema Online (SOL) Team.

CFP Additional Notes

- Strict User Policy Enforced the Freedom Pass is only available to client employees.
- Initial payment equal to 2 months fees with 10 further payments due monthly.
- SOL Corporate Freedom Pass was launched on 1st September 2021. SOL Freedom Pass does not attract additional single courses or Package Discounts.

Note - The Freedom Pass is not a package it is total access to all courses so there is currently no relevance for any previously offered discounts.

Corporate Freedom Pass Optimum Management

To enable the most efficient delivery of the program including the administrative management and enrollment process please take note of the following:

- We want you to benefit from the maximum use of the CFP so we ask you to nominate your program manager who will both manage your training Program, communicate enrollments with the Sofema Online Admin Team or has full control of registrations on the Auto Enrollment Process.
- After successfully completing each CFP, clients are eligible to receive complimentary soft copies of materials valued at up to 5, 7, 10, or 15 days' worth of training material, depending on the number of CFP slots purchased.

- We recognize that changes will occur during the day so any updates you provide will be added to previously requested and actioned during the daily updates
- With CFP you have a nominal availability of training days – CFP 5 (1200) – CFP 7 (1680) - CFP 10(2400) - CFP 15 (3600)

Concerning the Potential for Increased Utilization

- The nominal training days indicated does not include the weekends which are available if you choose to use.

To encourage full use of the system our admin support team is often available to support weekend daily enrollments.
